1. Message from WKO President

Dear Branch Chiefs and Contacts,

It is already a month and a half into the year, but I believe that all of you are busy with your daily activities in your country and region. In Japan, we are still experiencing cold weather, but based on the calendar, we have already entered spring.

Looking back, in February 2020, I was invited to the Guam Camp, enjoyed our training together in the beautiful nature and scenery, was blessed with warm hospitality, and just after my return to Japan, the COVID-19 problem started to surface in the world. It has passed so quickly, but we have been battling this problem for about 1 year. The battle is being prolonged due to the new variant, and in Japan, from early January, a state of emergency has been declared again for the main city areas, and we are strengthening our caution. Due to such circumstances, we promptly canceled the annual Kagami Biraki training that was planned just after the date of declaration. It is regretful that we could not carry out our training with strong kiai in front of Sosai Oyama's grave, but this was a moment to be patient, so we sent our thought and prayers to Sosai Oyama, who is watching over us from heaven.

As for the COVID-19 crisis, due to the hard efforts of the medical staff, and the vaccine process, we are starting to see advancements in this battle. It is important for us to always have a sense of appreciation and respect towards such efforts, and while following the infection prevention measures announced by the cabinet and local governments, we need to continue our training, maintain our dojos, organize competitions, and carry out our activities in a safe and secure manner. In March, the above-mentioned state of emergency is projected to be lifted, so we plan to organize the annual Dan Grading Exam for the Japan Region, and the Karate Dream Festival National Championship 2020 as scheduled. For the Dan Grading Exam, Kambu Iriki, who won the All Japan Championship last year, will also take the exam. Many strong non-WKO competitors participated in this tournament, and even in the unnatural conditions due to the COVID-19 crisis, he continued his hard training and gained a valuable victory. The fact that he is continuing his training and accepting new challenges, gives us hope for his further

development. Including Iriki, a total of approximately 30 examinees will take part, and I hope that they will train hard until the day of the exam, and carry out a deep conversation with their current mind and body.

For the Karate Dream Festival National Championship, many participants who are in need of a competition, will take part. I sincerely hope that you will train hard until tournament day, and demonstrate the results of your training in this difficult time with the COVID-19 crisis. As the organizers, including the above-mentioned Dan Grading Exam, in addition to carrying out basic measures such as monitoring the health of the competitors, to disinfect and ventilate, and to not allow spectators, we will also rotate the participants in groups, so that we can control the number of people in the tournament venue at every hour, and maintain a level that is well within the safety guidelines. We will make sure to secure safety, minimize the risk of infection, and do our best to meet the expectations and needs of the competitors. At the Tokyo Metropolitan Gymnasium, our sacred place, the competitors and related people will gather, and in strong unity, set an example for the world, by evolving the competition format in a way that can coexist with the current COVID-19 times. I hope that such efforts by the Japan Region will encourage our comrades around the world, and also demonstrate the role of Budo, and the clear direction for our activities, in this current society where we have to coexist with COVID-19. I sincerely request for the kind cooperation of all involved in this process.

On the other hand, there are still many problems that need to be solved to organize an international tournament. The travel to and from Japan is still under strict restrictions, and it is difficult to project when this will be eased. Due to such conditions, it was decided to postpone the 1st WFKO World Championship scheduled for this May, to September. For details, please confirm the official JFKO website. For this tournament, I can understand that it may be difficult for the selected competitors to maintain their mental and physical condition, but as the basic duty of a budoka, it is important for us to continue our hard training, so that we can fight at any time, regardless of the circumstances. All competitors will be taking part under the same condition, so how you adjust to this environment, will strongly influence your performance and result at the tournament. In this tournament that will test your strength as a human being, I will be expecting to see the result of your maximum efforts.

As for the Branch Chiefs and Contacts around the world, aside from a selected few, I have not seen most of you for a long time, since the World Championship in November 2019, and I hope that everything is going well with you. Due to the advancements in IT and technology, I am able to follow your events on social media, and please know that I enjoy your posts, and that such activities give me courage. Due to the prolonged COVID-19 crisis, I can understand the anxiety and concern you may have, but we are a big family that is connected by a strong Kyokushin spirit. Even in this unstable time, it is important for us to keep in mind our fellow family members, and with a kind heart, wear our pure white dogis, and continue our training around the world.

4. Annual fee exemption for Fiscal Year 2020

As was announced in past newsletters, the WKO Board has decided to exempt the annual fee for Fiscal Year 2020 (April 2020 to March 2021). For details, please reconfirm the following.

1. The annual fee for Fiscal Year 2020 (April 2020 to March 2021), is the annual fee 2021. This payment is going to be exempted for WKO as a whole.
2. The annual fee 2020 that needed to be paid in Fiscal Year 2019 (April 2019 to March 2020), by the deadline of March 2020, is still necessary, and for those who have not made the payment due to the coronavirus situation, WKO is willing to wait until the convenient timing for payment. However, this does not mean that Branch Chiefs/Contacts can prioritize belt orders and other payments over the unpaid annual fee. The annual fee still remains the basic duty and highest priority for Branch Chiefs/Contacts.
3. Due to this measure, all prepaid amounts for the annual fee 2021, will be switched over to the annual fee 2022, so that there is no contradiction in the payment records.

④. Invitation of Japanese Instructors

The WKO office receives numerous invitations for Japanese instructors every year. Standard procedure calls for the Official Invitation Letter to be sent to the WKO Office with the necessary information filled in. The invitation becomes official only when the letter arrives at the WKO Office. Please refrain from direct negotiations with Japanese instructors, for it will only lead to problems in the future. Finally, we would like for all to understand that an agreement based on direct negotiations will not be considered an official invitation.

⑤. Acceptance of Students from Overseas Branches

Every year, numerous students from overseas branches visit Japan for the purpose of training. When a student wishes to visit Japan for training, standard procedure calls for the Branch Chief or Contact (who the student belongs to) to contact the WKO Office of the ideal time frame, dojo, and detailed information (name, dan/kyu, age, etc.) of the student. The WKO Office will confirm the content of the request with the Branch Chief/Contact of the dojo in Japan. In a case where an overseas student goes forth with his/her training in Japan without consulting the WKO Office, it would delay the response time of the WKO Office if an emergency happened to occur. To assure the safety of the students, we ask for everyone's cooperation in this matter.

⑥. Centralization of communication between Overseas Branches

It is required that communication (related to events within the organization) between Overseas

WKO General Financial Situation for Fiscal Year 2019 (1 April 2019—31 March 2020)

The 12th World Open Karate Championship and the World Karate Seminar were the main activities for this fiscal year. Externally, as part of the worldwide standardization of Full Contact Karate, we promoted the realization of the 1st WFKO World Championship and the foundation of the international federation (WFKO). In the unification of the federation to manage the competition in the Full Contact Karate world, this was a very important year, even more than past years, where it was necessary for WKO to establish its originality as an organization that demonstrates quality and quantity, in the form of strength and scale. The full crowd at the above-mentioned World Championship, and the realization of 101 affiliated countries, were results that contributed to such establishment. These results secured the top position for WKO in the Full Contact Karate world, in a year that marked the 25th anniversary of the death of Sosai Masutatsu Oyama, the founder of Kyokushin Karate. Also at this important timing, the financial assistance towards the Oyama family, which had continued for the past several years, finished its final phase, due to the fulfillment of its meaning and purpose.

As for the settlement of accounts, the profit base is stable due to the continuing trend of the weak yen and increase in affiliated countries and members. Due to the holding of the WKO Grading Exam at the World Karate Seminar, there was a significant increase in the grading fee. The main difference between the numbers from the previous period is the financial support towards the host country and meeting fees for the above-mentioned World Championship, and the financial assistance towards the Oyama family.

■ Net Sales: ¥ 49,000,000 【Previous Period ¥41,700,000 (+¥7,000,000)】

The flat trend in the exchange rate and number of worldwide members, carried on from the previous fiscal year. For the grading fees, there is a significant increase in the orders from Europe and Japan. The WKO Grading Exam held at the World Karate Seminar was also a big factor, and contributed to the large increase (+6.6 million yen) compared to the previous period. The commission fee (1.7 million yen) from JFKO for the cooperation in organizing the 1st International Fullcontact Karate Championship was included in the previous period. Such main factors led to a 15% increase in net sales, which amounted to 49 million yen. The Yen rate at the end of March 2020 was 1 US Dollar = 109 yen (previous period 111 yen).

■ Gross Profit on Sales: ¥ 43,300,000 【Previous Period ¥36,700,000 (+¥6,600,000)】

The increase in purchase (belts) corresponds to the increase in dan promotions (+0.8 million yen). The cost of sales is based on Yen, and does not have any significant effect from the exchange rate. The increase in dan promotions was directly reflected in the result.

■ Sales, General & Administrative Expenses: ¥40,900,000 【Previous Period ¥26,600,000 (+14,300,000)】

The financial support (10 million yen) for the host country of the World Championship, the related fees (3.9 million yen) for the General Assembly and other meetings, and the purchase of flags (1 million yen) to mark

the achievement of 101 affiliated countries, were the main factors that contributed to this result. There are no other new expenses in this period, and this can be considered as the minimum amount necessary for the sales, general & administrative expenses. The above factors contributed to a 35% increase (compared to previous year) for a total of 40.9 million yen.

■ **Ordinary Profit: ¥2,200,000 【Previous Period ¥9,800,000 (-¥7,600,000)】**

Non-operating income includes the miscellaneous income from the visa support fee. In total, the increase in the gross profit on sales, played a big role in absorbing the increase in the sales, general, and administrative expenses related to the World Championship. Due to such factors, WKO was able to secure an ordinary profit of 2.2 million yen (decrease of 7.7 million yen compared to previous period), and solidified its profit base.

In addition, as in the balance sheet, the long-term borrowings from JKO amounts to 4.7 million yen, but WKO has 24 million yen as cash in bank. It can be said that WKO is a first-class NPO with a secure and stable profit base.

WKO Auditor Report for Fiscal Year 2019

Based on our auditing of the administrative and accounting procedures of WKO during 2019 April 1st to 2020 March 31st, we would like to report as follows.

【1】 Auditor Comments

The 12th World Open Karate Championship and World Karate Seminar were organized as the main activities for this fiscal year. As highlighted by the full crowd at the tournament, and the realization of 101 affiliated countries, WKO was able to carry out activities and demonstrate results in both quality and quantity.

The profit base is stable due to the continuing trend of the weak yen, and increase in affiliated countries and members. There is a significant increase in the grading fee, which is related to the organizing of the World Karate Seminar. The financial assistance towards the Oyama family, which had continued for some time, finished its final phase.

Despite the financial assistance of 10 million yen towards the host country of the World Championship, the meeting fees including the WKO General Assembly, and other related fees, the profit base is solid and stable. It can be said that WKO is a first-class NPO (non-profit organization) with a steady foundation to secure profit.

In terms of auditing, the equipment and documents in the office were organized in a neat manner, and enabled a smooth auditing procedure.

【2】 Auditor Report

(1) Outline of Audit Procedure

- ① For the auditing of accounting procedures, we considered the accuracy of the accounting documents utilizing all necessary measures, including the viewing of account books and related papers.
- ② For the auditing of administrative procedures, we attended meetings such as the Board Meeting and General Assembly, listened to administrative reports, and utilized all necessary measures to consider the appropriateness of the executed work.

(2) Result of Auditing

As a result of the above auditing, the accounting process was appropriate and precise. The administrative work was also properly executed based on the business plan.

WKO Auditors Gilbert Cleveringa and Abdurashid Khidirov agree and have approved of the content above.
