1. Message from WKO President

Dear Branch Chiefs and Contacts,

Thank you for your continuous cooperation and support for the further development of WKO. I hope that you were able to carry out your activities smoothly in January, the first month of 2022, a year full of hope. In Japan, although the weather is still quite cold, according to the calendar, February 4th will mark the beginning of the spring season, and with the blossoming of the plum trees, the weather will gradually become warm, and we will start to feel the coming of spring.

As WKO, we started our activities for the year with the Kagami Biraki training on January 9th. Since the training for last year was canceled due to the COVID-19 crisis, it had been 2 years since our last event. Approximately 220 members gathered at Gokokuji Temple, where Sosai Oyama rests in peace, and under the clear blue skies, and with our minds and bodies covered in our pure white dogis, we carried out Kihon with Kiai, and demonstrated our appreciation towards Sosai Oyama with special demonstrations. It was a great pleasure, especially in this COVID-19 crisis, where various activities are restricted, to gather at this sacred place with important comrades, and in the cold and strong wind, with the mind free, carry out Tsuki and Keri with Kiai.

The coexistence with COVID-19, which has continued for almost 2 years, has forced the postponement or cancellation of many international tournaments. The 1st World Championship, the global flagship of Full Contact Karate, was also decided to be canceled. For the 7th World Championship in Weight Categories, which we are planning to hold this September in Poland, I would like to realize this event by all means. Despite the various restrictions, it is important to move WKO forward, by holding selection tournaments in each region. I believe that WKO Poland, the host country for the event, is shouldering a heavy burden with the preparation work. Let us join hands, and overcome each issue and task, one by one, in order to realize this tournament. Although I have not been able to meet with the Branch Chiefs and Contacts around the world for almost 2 years, I am sincerely looking forward to the day when we will be able to happily reunite,

after overcoming the global problems.

In the Full Contact Karate world, Japan led the movement by founding the Japan Fullcontact Karate Organization, and as the foundation of the international federation, various activities have been carried out. With the holding of the national championship 6 times, and the international championship in 2018, many groups and organizations have come together, giving shape to the united front. In March 2022, the 1st All Japan Youth Fullcontact Karate Championship will be held in Tokyo, at the Yoyogi National Stadium First Gymnasium. In this tournament, despite the COVID-19 crisis, 1,277 competitors from young children to high school students will participate, and in 58 categories divided by age, gender, and weight, they will compete to become the winner of the national championship at the highest level. Approximately half of the competitors are from WKO Japan. I wish for them to represent WKO with honor and fight fairly until the end, and through a friendly rivalry with the strong competitors of various Full Contact Karate groups, demonstrate the greatness of Full Contact Karate to society, and also present the need for a glorious stage, through the inclusion of the competition into the Olympic Games. The formation of the united front, will become the foundation of this great dream for the future. I would like for the various regions in the world, to take the activities in Japan as an example, and build up the momentum towards the united front. On the other hand, in this trend of diversity, it is important for WKO, not to get caught up or swallowed in this movement, and maintain a strong color of individuality. To cherish the ideas and uniqueness of the instructors around the world, and by gathering and piling them together, let us further develop a wonderful organization.

For the students that train Full Contact Karate around the world, I would like for you to continue your trainings as much as possible, in the environment that is presented to you, regardless of the difficulties and restrictions you are faced with. I believe that you made the decision to join the dojo, with the intention to change yourself in a good way. The trainings are not always fun, and can be hard and tough at times. When faced with such difficulty, it is important not to worry, and simply go to the dojo, to meet your Shihan and comrades. With this one step, you will be able to find a new side to yourself, and I sincerely believe and hope that you will become victorious in life. On the other hand, it is important for the instructors to accept such feelings of the student, and guide them so that they can overcome the hard and tough trainings with happiness and enjoyment. The instructor full of passion, and a dojo full of smiles, and the collection and gathering of these, will become the individuality of WKO. Let us continue our efforts and movement forward, so that as an organization, we can have the strength to change all forms of suffering into happiness.

④. Invitation of Japanese Instructors

The WKO office receives numerous invitations for Japanese instructors every year. Standard procedure calls for the Official Invitation Letter to be sent to the WKO Office with the necessary information filled in. The invitation becomes official only when the letter arrives at the WKO Office. Please refrain from direct negotiations with Japanese instructors, for it will only lead to problems in the future. Finally, we would like for all to understand that an agreement based on direct negotiations will not be considered an official invitation.

⑤. Acceptance of Students from Overseas Branches

Every year, numerous students from overseas branches visit Japan for the purpose of training. When a student wishes to visit Japan for training, standard procedure calls for the Branch Chief or Contact (who the student belongs to) to contact the WKO Office of the ideal time frame, dojo, and detailed information (name, dan/kyu, age, etc.) of the student. The WKO Office will confirm the content of the request with the Branch Chief/Contact of the dojo in Japan. In a case where an overseas student goes forth with his/her training in Japan without consulting the WKO Office, it would delay the response time of the WKO Office if an emergency happened to occur. To assure the safety of the students, we ask for everyone's cooperation in this matter.

⑥. Centralization of communication between Overseas Branches

It is required that communication (related to events within the organization) between Overseas Branches and Japanese Branch Chiefs & Contacts be exchanged through the WKO Office. Translation of documents (Japanese⇔English) will also be managed by the WKO Office. In order to avoid any unnecessary problems and confusion, we ask for everyone's cooperation in the centralization of communication between overseas branches.

WKO General Financial Situation for Fiscal Year 2020 (1 April 2020—31 March 2021)

1. Activity Overview

With the holding of the 12th World Open Karate Championship in the previous fiscal year, WKO entered a new four-year activity period. For this fiscal year, in relation with the Tokyo 2020 Olympics, the further progress in the world standardization of Full Contact Karate was planned, mainly with the holding of the 1st WFKO World Championship, but due to the emergence of COVID-19 and its spread worldwide, there was no choice but to postpone such plans. In the international sports world, as symbolized in the postponement of the Tokyo 2020 Olympic Games (organized in August 2021), sports federations were required to adjust to serious and wide restrictions on activities for a long period, and the battle with the unknown virus, and measures to coexist with it were carried out. Naturally, such drastic change in environment also affected WKO. The postponement of the European Championship, the limited organizing of the All Japan and All Russian Championship, the dojo trainings and camps in various regions, the scaling down or suspension of gradings, and other wide-range effects on activities. The postponement of the 7th World Karate Championship in Weight Categories (Poland), originally scheduled to be organized in 2021, was also decided at an early stage.

2. Financial Overview

Although the shrinking of activities worldwide, clearly affected the settlement of accounts, due to the cumulated surplus in recent years, WKO was able to limit the effects, and also carry out financial assistance by exempting the annual fee for this fiscal year, as a sign of appreciation towards the continuous cooperation from the affiliated branches and dojos. In addition, to support the activities of the branches/dojos, the WKO Headquarters announced to the world, a guideline with measures to prevent COVID-19 infection at dojos, for the collective consideration of effective ideas. Such policies were announced and shared through the newsletter, while considering the mind and feelings of WKO members, strengthening the bond of friendship within the organization. In terms of PR, especially in relation to the other Full Contact Karate groups, there are expectations that WKO was able to effectively promote the benefits and values of being affiliated to the organization. For the settlement of accounts, in terms of income, there was a downturn due to the exemption of the annual fee and the decrease in the grading fee from the limited activities. In the non-operating sector, the receiving of public subsidies related to COVID-19 was a positive development. On the other hand, for the expenses, since the financial support for the host country (Japan) of the 12th World Open Karate Championship was included in the previous fiscal year, in comparison, the sales, general & administrative expenses was significantly reduced for this period. In general, the settlement of accounts is in the red due to the COVID-19 crisis, but the loss was absorbed by the cumulated surplus.

■ Net Sales: ¥17,000,000 [Previous Period ¥49,000,000 (-¥32,000,000)]

The decrease (-¥24,000,000) due to the exemption of the annual fee for this period is significant. For the grading fees, the registration fee was revised, but the number of orders from various regions, especially

Europe and North America, decreased (-¥9,000,000). This sector took a direct hit from the effects of COVID-19, but even in such situation, new branches were opened. Especially, there are high expectations for the activities of the Turkey Branch, led by Branch Chief Muzaffer Bacak, the 7th World Open Karate Championship Finalist. Such main factors led to a 66% decrease in net sales, for a total of 17 million yen. The Yen rate at the end of March 2021 was 1 US Dollar = 110 yen (previous period 109 yen).

■ **Gross Profit on Sales: ¥ 14,000,000 【Previous Period ¥43,000,000 (-¥29,000,000)】**

There was a 57% decrease in purchase (belts), corresponding with the decrease in dan promotions. The rate of decrease is sharper compared to the decrease in the grading fees (-35%), but this is due to the revision of the dan registration fee. The cost of sales is based on Yen, so the effect from the exchange rate is very limited. The decrease in net sales was directly reflected in the result.

■ **Sales, General & Administrative Expenses: ¥20,000,000 【Previous Period ¥41,000,000 (-21,000,000)】**

The reasons behind the large difference compared to the previous period, are the fees (15 million yen) related to the 12th World Open Karate Championship (financial support for host country, meeting expenses, flags of affiliated countries, etc.), and the financial assistance (2 million yen) towards the Oyama family. The use of communication equipment within the WKO Headquarters was reconsidered, and this led to a decrease in cost of 1 million yen. The above factors contributed to a 50% decrease (compared to previous year) for a total of 20 million yen.

■ **Ordinary Loss: ¥-4,000,000 【Previous Period ¥2,000,000 (-¥6,000,000)】**

Non-operating income includes the public subsidies (2 million yen) related to COVID-19 from the Government of Japan. In total, the main factors behind the difference compared to the previous period, are the costs related to the 12th World Open Karate Championship in the previous year, and the decrease in income due to the COVID-19 crisis and the financial assistance towards the affiliated countries in this fiscal year. As a result of such activities, WKO finished the fiscal year with a loss of 4 million yen, but the fact that such loss was absorbed by the cumulated surplus in recent years, demonstrates the growth of the organization.

In addition, as in the balance sheet, the nondebt management of WKO is being continued, with 17 million yen secured as retained earnings brought forward.

WKO Auditor Report for Fiscal Year 2020

Based on our auditing of the administrative and accounting procedures of WKO during 2020 April 1st to 2021 March 31st, we would like to report as follows.

【1】 Auditor Comments

For this fiscal year, due to the COVID-19 crisis and pandemic, various tournaments were postponed, camps and gradings were scaled down or suspended, and other wide-range effects were confirmed on activities. Although the shrinking of activities worldwide, clearly affected the settlement of accounts, due to the cumulated surplus in recent years, WKO was able to limit and minimize the effects.

For the settlement of accounts, in terms of income, there was a downturn due to the exemption of the annual fee and the decrease in the grading fee from the limited activities. For the expenses, since the financial support for the host country (Japan) of the 12th World Open Karate Championship was included in the previous fiscal year, in comparison, the sales, general & administrative expenses was reduced for this year. In addition, the decrease in cost due to the reconsideration of the use of communication equipment within the WKO Headquarters is a positive development.

Despite the public subsidies (2 million yen) related to COVID-19 from the Government of Japan, due to the decrease in income related to the COVID-19 crisis and the financial assistance towards the affiliated countries, WKO finished the fiscal year with an ordinary loss of 4 million yen, but was able to absorb it with the cumulated surplus in recent years. As in the balance sheet, with the continuous nondebt management of WKO, it can be said that WKO is a first-class NPO (non-profit organization). In terms of auditing, the equipment and documents in the office were organized in a neat manner, and enabled a smooth auditing procedure.

【2】 Auditor Report

(1) Outline of Audit Procedure

- ① For the auditing of accounting procedures, we considered the accuracy of the accounting documents utilizing all necessary measures, including the viewing of account books and related papers.
- ② For the auditing of administrative procedures, we attended meetings such as the Board Meeting and General Assembly, listened to administrative reports, and utilized all necessary measures to consider the appropriateness of the executed work.

(2) Result of Auditing

As a result of the above auditing, the accounting process was appropriate and precise. The administrative work was also properly executed based on the business plan.




