2. Doping Test

The doping test on September 25 (Sun.) will be held under the initiative of the organizer and the Anti-Doping Agency of Poland, with the attendance of WKO Anti-Doping Committee members. We ask for all competitors to carefully confirm the relevant news and information on the WADA website (URL: <u>https://www.wada-ama.org/en</u>), in order to be familiar with the latest anti-doping information and situation before the tournament.

3. No acceptance of WKO payments

In order to avoid any possibility of theft, misplacement, and complications during immigration, we ask that Branch Chiefs/Contacts refrain from making any official payments (Annual Fee, Black Belt, etc.) to WKO members during the event, and no exceptions will be accepted. Please also understand that we will not be able to take any belts and certificates with us to Poland, for the tournament related equipment and items are of the highest priority.

4. The official hotel will be Hotel Binkowski



- The weight categories at the 8WC in Weight Categories and after (Japan & Europe Region)
 Proposed Change: <u>Men -60kg/-70kg/-80kg/-90kg/+90kg</u> Women -48kg/-53kg/-58kg/-63kg/+63kg
 - → The weight categories for Men were approved at the previous WKO Board Meeting in 2019. This time, the categories for women are proposed, to be introduced (with the Men categories) at the next WC in Weight Categories. [The European proposal was +5kg for Men, and +2kg for Women] (reference information)
- ② How to form the referee list and also improve fairness (Europe Region) Reason of proposal: Referees should not referee competitors from the same country. This is an effective way to maintain fairness in the competition. As for the details, it is proposed to form the referee teams before each round.

- ③ How to form the tournament draw and also improve fairness (Europe Region)
- Reason of proposal: When forming the tournament draw, to announce the standards (competition rank of fighters, region/country, etc.) to the public, organize the elements that will be considered when making the draw, and put a high priority on fairness and objectivity. To use a computer software, and based on clear standards, form the draw in an open/public manner. EKO can provide the necessary programs and software.
- ④ Introduction of the Kata competition in the World Championship (Europe Region) Reason of Proposal: There are many competitors that wish for a Kata World Championship to be held. There needs to be a stage or tournament for such competitors. The WKO Referee Committee can make the rules for this competition/tournament.




