1. Message from WKO President

Dear Branch Chiefs and Contacts,

This will be the last newsletter for this year. In Japan, the ginkgo leaves that decorated the cities with beautiful colors, have spread throughout the streets like a yellow carpet due to the cold wind. The weather is getting colder, and the season has changed quietly from late autumn to winter. I believe that the Branch Chiefs and Contacts around the world are currently busy with various year-end activities, but I hope that you are in good health and that everything is going well.

This year was highlighted by the prolonged COVID-19 pandemic, the confusion in the international community symbolized by the situation in Ukraine, and the slowdown in growth of the world economy, all leading to a stagnant mood throughout the year. However, as WKO, we organized the long-awaited 7th World Championship in Weight Categories, and we sensed a light of hope for the resuming of activities and events worldwide. Thanks to the cooperation of the Branch Chiefs and Contacts worldwide, we will be able to get through this eventful year.

In Japan, in relation to the postponement of the World Championship in Weight Categories, the traditional All Japan Open Karate Championship was also postponed to December, and the venue was changed from the Tokyo Metropolitan Gymnasium to the Yoyogi National Stadium Second Gymnasium. By the time you will read this newsletter, the Japanese competitors participating in the tournament will be carrying out their last training and conditioning for the competition. I hope that the competitors will take extra care in the last preparation for the tournament, and demonstrate brilliant kumite at this sacred stage. I have high expectations for your great performance. Since this will be the first selection tournament to decide the Japan National Team for the 13th World Open Karate Championship that will be held on October 14-15, 2023 in Tokyo, fierce battles are expected. I kindly ask for your warm encouragement and support towards the Japan Region competitors that will face the strong non-WKO competitors in the last big tournament of the year.

I believe that the activities related to the World Championship are also being held in other countries and regions around the world. I sincerely hope that various issues can be cleared, so that the Branch Chiefs and Contacts worldwide can be reunited at the World Championship next year. For the comrades that are not able to participate in international events due to the international problem related to the situation in Ukraine, you are always in my heart, and I will continue to wait for the moment we can be reunited. The WKO Headquarters has already started the preparation work for the World Championship. I believe that the Board Members around the world are busy with the selection tournaments and related events, but I ask for your kind support so that the competitors can shine. At this tournament, we will organize the Kata Championship for the first time, so for the competitors who are especially focusing on the art of Kata, please polish and train your mind, body, and techniques to prepare for the event. Let us promote to the world, a new appeal of Full Contact Karate, through the solid and powerful techniques, polished and trained through the exchange of full contact offense and defense. The information related to the competition and operation will be announced when the details are fixed, so please give us some more time to provide you with the related information.

In October of this year, the WKO Headquarters office was relocated and expanded. On the other hand, nothing has changed with the Sohonbu Dojo, which is continuing various activities in Shinjuku. In recent years, in addition to the existing activities and events related to the organization, the scale and content of the operations have expanded, especially with the administrative and operational work related to JFKO/WFKO. We inherited the Kyokushin spirit founded by Sosai Oyama, and we have overcome the difficult times after the passing of Sosai. Since it will mark the 20th year since we started our new history and path as Shinkyokushinkai in 2003, this relocation was planned and executed. The new office is located near the foot of the Tokyo Tower, which is the symbol of Tokyo, and is close to many of the embassies in the world. The view from the window is great, and is fitting for the Headquarters of WKO, which is spread across the world. I hope that you will visit the new office at the occasion of the World Championship next year.

Although this is a personal matter, my mother passed away in November, and I received many messages of encouragement and sympathy from around the world. I would like to express my sincere appreciation towards your kindness and warm support. It became an opportunity for me to reconfirm and hold deep inside my heart, the importance of the Kyokushin spirit and the teachings of Sosai Oyama, “keep your head low, eyes high, mouth shut; base yourself on filial piety and benefit others”. I hope that all of you will take good care of your parents, and even more than before, be devoted and kind to them.

I mentioned this in the beginning as well, but the eventful 2022 will soon end, and we are starting to hear the footsteps of 2023, a year full of hope. I wish for WKO, as the largest Full Contact Karate organization in the world with 103 affiliated countries and areas, to be an organization that is able to adjust and respond quickly to various changes that will occur with the passing of time. I also believe that our organization needs to be full of smiles from all of the related members. The international community is still in a difficult situation, but it is important for such hardship to be shared, and with the kindness to consider and sympathize, I hope that we

5. Report of annual fee payment, regional activities, and doping samples

Branch Chiefs/Contacts are asked to report the number of their students as of the end of December 2022 and the estimated payment of their Annual Fee 2023 (USD\$1~USD\$4 per member) by January 31 (Tue.), 2023. This is a very important step that leads to the actual payment in March 2023, so we would like for your kind cooperation towards the matter. WKO Board Members are also asked to report by the same date, the main events (tournament, grading, etc.) hosted by their regions in 2023.

Also, each region is asked to report the number of doping samples tested by their region in 2022 by the same date (January 31). For regions that do not have a WKO Anti-Doping Committee Member (North America, South America, Middle East), the WKO Board Member of the region is expected to make the report on behalf of the respective region. The overall number of samples tested by WKO in 2022, will be announced in the Newsletter that will be issued in late February (which will be the March 2023 Newsletter).

④. Invitation of Japanese Instructors

The WKO office receives numerous invitations for Japanese instructors every year. Standard procedure calls for the Official Invitation Letter to be sent to the WKO Office with the necessary information filled in. The invitation becomes official only when the letter arrives at the WKO Office. Please refrain from direct negotiations with Japanese instructors, for it will only lead to problems in the future. Finally, we would like for all to understand that an agreement based on direct negotiations will not be considered an official invitation.

⑤. Acceptance of Students from Overseas Branches

Every year, numerous students from overseas branches visit Japan for the purpose of training. When a student wishes to visit Japan for training, standard procedure calls for the Branch Chief or Contact (who the student belongs to) to contact the WKO Office of the ideal time frame, dojo, and detailed information (name, dan/kyu, age, etc.) of the student. The WKO Office will confirm the content of the request with the Branch Chief/Contact of the dojo in Japan. In a case where an overseas student goes forth with his/her training in Japan without consulting the WKO Office, it would delay the response time of the WKO Office if an emergency happened to occur. To assure

the safety of the students, we ask for everyone's cooperation in this matter.

⑥. Centralization of communication between Overseas Branches

It is required that communication (related to events within the organization) between Overseas Branches and Japanese Branch Chiefs & Contacts be exchanged through the WKO Office. Translation of documents (Japanese⇔English) will also be managed by the WKO Office. WKO General Financial Situation for Fiscal Year 2021 (1 April 2021 – 31 March 2022)

1. Activity Overview

This fiscal year was the 2nd year of the COVID-19 crisis, and the mind to coexist with COVID-19 has gradually started to spread, but the restrictions on the international travel of people still remain. On the other hand, after a 1-year postponement, the Tokyo 2020 Olympic Games was held despite the smaller scale, and the expectations increased for the resuming of international sports events. As for WKO, regional tournaments in Japan, Europe, and Russia were held in a smaller scale compared to normal standards, but in Asia and other regions, the planned events were canceled. Especially for the 1st WFKO World Championship, efforts were made to organize the event in some way, but unfortunately, the tournament was canceled. There are also restrictions in the operation of the dojo trainings, camps, and grading exams. The 7th World Karate Championship in Weight Categories (Poland) that was scheduled for 2021, was eventually postponed to September 2022, and despite the uncertain elements, the tournament is expected to be held as planned. In such situation, the world was taken by shock, due to the sudden passing of Shihan Kalman from Hungary, and Shihan Muthukumarana from Sri Lanka.

As for the Japan Region, despite the COVID-19 crisis, the 53rd All Japan Open Karate Championship and the Karate Dream Festival, which had approximately 1,500 participants from young children to seniors, were organized together in December. In March, the JFKO Youth Championship with approximately 1,200 participants was organized successfully. With the holding of such large-scale events, positive energy was shared not only within WKO, but also with the Full Contact Karate practitioners around the world, and it demonstrated the organizational strength of WKO, inside and outside of the organization.

On the other hand, although there was a plan to hold a World Online Joint Training in late February during the All Japan National Team Training Camp, due to the start of the Russian invasion of Ukraine, the plan had to be canceled in a hurry. The fact that a serious international problem surfaced at the end of the fiscal year, in the midst of high expectations for the closure of the COVID-19 crisis, caused disappointment and sadness for the WKO affiliated countries around the world.

2. Financial Overview

In the previous fiscal year, the worldwide exemption of the annual fee was carried out as a part of the financial support due to the COVID-19 crisis, but for this fiscal year, it was returned to the normal standard. In general, although there is a slight stagnation in the profit, mainly with the dan grading fees due to the COVID-19 crisis, the trend is moving upward. For the regional ratio of the income for the organization, in 2018 & 2019, the Japan Region and Europe Region combined to account for over 60%, and for 2020 & 2021, this increased to over 70%. Due to the large-scale transfer (from another organization) that happened in Poland in 2010, the affiliated countries in Europe have increased, and that has contributed to the strengthening of the revenue base. There is a high expectation for a similar trend in other regions as well, so that the expansion in the organization will lead to an increase in profit. In addition, the ratio of the Japan Region for the income in this fiscal year was 42%.

■ **Net Sales: ¥ 44,000,000 【Previous Period ¥17,000,000 (+¥27,000,000)】**

Due to the worldwide exemption of the annual fee in the previous period, there is a balance in the income, and for this period, the net sales increased by 27 million yen. For the dan grading fees, although it is less compared to the 25 million yen in fiscal year 2019, it recovered significantly (to 20 million yen) from the previous period. The number of members for the grading registration in this period was 792, compared to 649 in the previous year. The revision of the grading fees in January 2020 is also a positive development for the income of WKO. Such main factors led to a 265% increase in net sales, for a total of 44 million yen. The Yen rate at the end of March 2022 was 1 US Dollar = 122 yen (previous period 110 yen). It goes without saying that in general, the weaker Yen is resulting in an increase in profit for WKO.

■ **Gross Profit on Sales: ¥ 41,000,000 【Previous Period ¥14,000,000 (+¥27,000,000)】**

The products purchased are mainly black belts for the dan gradings. Corresponding with the increase in dan grading registrations, the purchase of black belts increased by 18% compared to the previous period. The cost of sales is based on Yen, so the effect from the exchange rate is limited. The increase in net sales was directly reflected in the result.

■ **Sales, General & Administrative Expenses: ¥22,000,000 【Previous Period ¥20,000,000 (+2,000,000)】**

This increased slightly compared to the previous period. The main factors behind the difference are the renewal of the website (0.7 million yen) and the rise in expenses due to the increase in the WADA annual fee (0.8 million yen). In general, the result was a 7% increase (compared to previous year) for a total of 22 million yen.

■ **Ordinary Profit: ¥19,000,000 【Previous Period -¥4,000,000 (+¥23,000,000)】**

For the difference in the non-operating income, the previous period included the public subsidies (2 million yen) related to COVID-19 from the Government of Japan. In total, the increase in profit due to the return of the annual fee, and the gradual resumption of dojo activities in the 2nd year of COVID-19 contributed to an increase of 23 million yen compared to the previous period, finishing the fiscal year with an ordinary profit of 19 million yen.

In addition, as in the balance sheet, the nondebt management of WKO is being continued, with 36 million yen secured as retained earnings brought forward.

WKO Auditor Report for Fiscal Year 2021

Based on our auditing of the administrative and accounting procedures of WKO during 2021 April 1st to 2022 March 31st, we would like to report as follows.

【1】 Auditor Comments

For this fiscal year, which was the 2nd year of the COVID-19 crisis, the restrictions on international travel still remain. The tournaments in Japan and Europe are held despite the smaller scale, but in Asia and other regions, the planned events were canceled, and there are also restrictions in the operation of dojo trainings, grading exams, and other events. Within the 103 affiliated countries and areas in WKO, there are 38 countries without any annual fee, dan grading, and registration payments, so the resuming and expanding of activities is expected and necessary for the increase in income for WKO. For the regional ratio of the income for the organization, the Japan Region and Europe Region combined to account for over 70%.

For the settlement of accounts, in the previous year, the worldwide exemption of the annual fee was carried out as a part of the financial support due to the COVID-19 crisis, but for this fiscal year, it was returned to the normal standard. In general, although there is a slight stagnation in the profit due to the effects of COVID-19, the trend is moving upward.

With the increase in profit due to the return of the annual fee, the income from the dan grading fees, and the gradual return of activities and easing of restrictions due to the 2nd year of COVID-19, WKO finished the fiscal year with an increase of 23 million yen (compared to the previous period), securing an ordinary profit of 19 million yen. It can be said that this is a good result, and with the continuous nondebt management, WKO demonstrated again that it is a first-class NPO (non-profit organization).

In terms of auditing, with the relocation to the new office with more space, the equipment and documents were even more organized in a neat manner, and enabled a smooth auditing procedure.

【2】 Auditor Report

(1) Outline of Audit Procedure

- ① For the auditing of accounting procedures, we considered the accuracy of the accounting documents utilizing all necessary measures, including the viewing of account books and related papers.
- ② For the auditing of administrative procedures, we attended meetings such as the Board Meeting and General Assembly, listened to administrative reports, and utilized all necessary measures to consider the appropriateness of the executed work.

(2) Result of Auditing

As a result of the above auditing, the accounting process was appropriate and precise. The administrative work was also properly executed based on the business plan.

WKO Auditors Gilbert Cleveringa and Abdurashid Khidirov agree and have approved of the content above.




